## WTA Technologies GmbH and UNISOL Membrane Technology GmbH merge to form WTA UNISOL GmbH.

Last year the shareholders of WTA Technologies (WTA) and the German part of UNISOL Membrane Technology (UNISOL) agreed to a merger forming WTA UNISOL GmbH.

By joining with WTA, UNISOL consolidates its presence in Europe and at the same time opens the company's international orientation. UNISOL's sales networks and locations in America, China and India simultaneously provide the newly formed German company WTA UNISOL GmbH with direct access to global markets.

According to Carsten Bachert, Managing Director "...the WTA and UNISOL product areas are 100% complementary and at the same time the markets are also often congruent. Thus, we have already been cooperating successfully for two years in the areas of sales, procurement, and production. This successful cooperation ultimately led to the logical conclusion that 1+1 can be more than 2 and that upcoming milestones can be reached faster and more efficiently together. "

The location of the merged company is in the "Kindlebener Feld Industrial Park" in Gotha, Germany, where WTA Technologies opened its headquarters with an attached production facility in 2018. With a financing volume of several million euros, WTA originally invested in state-of-the-art machine technology and know-how to produce membrane modules for the treatment of water, wastewater and process water. Today, WTA products provide the highest levels of treatment including the removal of microplastics and multi-resistant pathogens from the water cycle.

UNISOL manufacturers micro-, ultra-, nanofiltration and reverse osmosis flat sheet membranes. It also produces state-of-the-art modules, such as DT modules and spiral wound elements, designs for niche processes and specialty applications in membrane technology. Walter Lamparter, Managing Director, added "...that especially the current crises show that solutions are needed in the field of environmental technology, treatment and recycling of water and process streams. WTA UNISOL is ready with its innovative technologies."

In the future, all German sales activities, product and process development, engineering, services and production will be bundled at the Gotha headquarters. Over the last two years, WTA built a fully automated production facility based on the model of Industry 4.0. Equipped with cutting edge information and communication technologies, multiple production steps can be simultaneously mapped and the entire value chain optimized. This makes it possible to consider all phases of the product life cycle, from the idea to development, sales and marketing, manufacturing, use and maintenance, and to recycling.
